MIINUTES OF THE MEETING OF BOARD OF DIRECTORS April 17, 2017

Notice of the meeting was sent to each Director and posted on the property prior to the meeting in accordance with the Bylaws of the Association and the requirements of the Florida Statutes. The following Directors were present,

A quorum was declared to be present.

Brian Rivenbark from Sunstate Management was in attendance.

UNDER THE HEADING OF APPROVE MINUTES: On a motion by Elsie Merrill, seconded by Mary Gibbs, the minutes of the March 20, 2017 Board meeting were unanimously approved.

UNDER THE HEADING OF TREASURER'S REPORT:

UNDER THE HEADING OF COMPLIANCE AND VARIANCE:

A. COMPLIANCE: Brian presented the April compliance report with 4 Homeowners set to be sent to the Appeals Committee. Those homes are 606 Pine Ranch East Road, 624 Oak Bay Drive, 818 Oak Pond Drive and 593 Pine Ranch East Road. Brian stated that he contacted 606 PRE, 624 OBD and 593 PRE. 606 PRE will have the palms trimmed within a week, 624 OBD complied and had the palms trimmed and 593 PRE will have their palms trimmed within a week.

A **MOTION** was made by Jeff Cole and seconded by Elsie Merrill to impose a fine of \$1000.00 on 818 Oak Pond Dr for yard maintenance violation. **Motion passed unanimously.**

Brian will ask Charlie Dudley to chair the Appeals Committee.

615 Oak River Court will be notified that they need to do something about the smashed garage door.

Brian will notify 817 Oak Pond Drive that they need to back into their driveway so the commercial sign on their rear window is not visible.

B. VARIANCE: None

UNDER THE HEADING OF OLD BUSINESS:

- Brian presented the current A/R to the Board and advised that all past due accounts will need to be handed over to the Attorney. Lengthy discussion followed regarding the past due accounts.
- A **MOTION** was made by Elsie Merrill and seconded by Karla Lehn to send 579 Oak Bay Dr, 583 Pine Ranch Rd and 500 Oak Bay Dr to the Attorney for collections. **Motion passed unanimously.**

- Brian stated that 814 Oak Pond Dr has completed their action plan to comply with all the violations attached with their home. Brian suggested to the Board to waive the fine imposed for these violations. Brief discussion followed regarding the waiving of the fine.
- A **MOTION** was made by Karla Lehn and seconded by Jeff Cole to Waive the fine of \$1000.00 on 814 Oak Pond for correcting the violations. **Motion passed unanimously.**

UNDER THE HEADING OF NEW BUSINESS:

- Jeff suggested to Brian to draft a spreadsheet of all the rental homes in Bay Oaks to show if the rental application was completed and when the lease at that unit is due.
- Jeff suggested getting a memorial to Tate Volino. The Board suggested getting a tree memorial. Karla stated that a Yesterday, Today and tomorrow tree would be a good idea. Brief discussion followed regarding the memorial.
- A **MOTION** was made by Mary Gibbs and seconded by Elsie Merrill to purchase a Yesterday, Today and tomorrow and have it planted at the south entrance in memorial of Tate Volino. **Motion passed unanimously.**
- The Board would like to have a ceremony on May 27th, Memorial Day for Tate.

With no further business before the Board, a motion was made and seconded to adjourn the meeting at 7:47 P.M.
